The purchase price of this cat/kitten is US \$ _____ and shall be payable in full prior to the release of cat/kitten to purchaser. Purchaser is responsible for all shipping charges also to be paid in full prior to shipping.

Seller will supply CFA and TICA registration papers and pedigree.

Purchaser agrees to the Following:

1) ONE GENERATION RESTRICTION ON ANY OFFSPRING FROM ABOVE CAT!! ALSO SAID CAT IS NOT TO BE RESOLD OR LEASED OR CO-OWNED WITH ANY OTHER PARTIES WITHOUT CATERABLU'S WRITTEN PERMISSION.

2) Purchaser will take responsibility to assure all kittens produced annually by this breeder cat receive good homes and adequate care.

- 3) Provide adequate health care for this cat/kitten, which minimally reduces annual immunizations and treating internal and external parasites. Competent, licensed veterinarian care shall be obtained immediately upon any signs of illness.
- 4) Under no circumstances is this cat/kitten ever to be allowed to roam outdoors.
- 5) Seller makes no guarantees to show quality of this cat/kitten.
- 6) If this cat/kitten cannot be cared for any longer, Purchaser agrees to contact Seller first for new placement options. Placement in a new home will be pursued by the Seller.
- 7) This cat/kitten comes from a FeLV Free Cattery, meaning no cat(s) /kitten(s) test positive for FeLV nor are they vaccinated for FeLV
- 8) **Vaccinations with FeLV vaccine VOIDS all health guarantees.**
- 9) FIP is an uncommon disease that is not 100% preventable. Seller waives liability for FIP and any related veterinary expenses. Seller suggests the Purchaser should take out a Veterinary Insurance on the cat/kitten for 2 years.
- 10) I have bred selectively in order that your kitten may have a long and healthy life. Every cat/kitten purchased from Catera Cattery will be fully **vet-checked and certified to be healthy and free of any disease or parasites at the time of sale.**
Once my Vet has certified the kitten as being healthy, I am no longer responsible for the kitten after he/she has left my home with all paper work (medical records). I cannot control the stress of the kitten when they leave my home, nor can I be held responsible for any illness the kitten may contract or injury he/she may sustain while in your care!
- 11) Purchaser is responsible for all veterinarian fees from the date and time of shipping.
- 12) Return of cat/kitten for health reasons will be at Purchaser's expense, **MUST** have been identified by a licensed veterinarian and be accompanied by the veterinarian's initial examination statement, showing that health problem(s) exist **AND that the health problem must have existed prior to the sale** of the cat/kitten.
Stress induced URI is **not** covered in this medical statement.
- 13) Seller's remedy for any health problems covered in this contract will be limited to replacement of cat/kitten with another cat/kitten of equal value.
This Guarantee is limited to replacement of cat/kitten only at earliest availability- NO REFUNDS!
- 14) Payments and deposits are non- refundable unless Seller cannot supply the above cat/kitten

NOTE: The buyer is responsible for picking up their kitten, or see if it can be shipped out of Montgomery Airport. THE BUYER PAYS FOR AIR FLIGHT

ANY DISPUTE CONCERNING THIS SALE WILL BE CONDUCTED IN ELMORE COUNTY IN THE STATE OF ALABAMA

This document is a legal and binding contract. The laws of the United States of America will be controlling. There are no other conditions or guarantees, verbal or implied. In the event the purchaser is found to have violated any of the terms of this contract, the purchaser shall be liable to the Seller for damages in the amount of the purchase price of said cat/kitten, plus expenses for veterinarian care and any attorney or legal fees that might result in litigating this contract.
