Catera Cattery's Russian Blues and Singapuras are raised with a great deal of care and love. I am as concerned about their health and personalities as I am their beauty. My goal and reason for breeding is to maintain and improve the breed and to provide you with a delightful addition to your home for many years to come.

NON REFUNDABLE DEPOSIT REQUIRED: \$ 300.00

The kitten has been sold to you in good faith as sound in body and temperament, and will not be allowed to leave **Catera Cattery** if there is any indication of illness. It is recommended that you take your kitten to your veterinarian (at your own expense) for a thorough examination within five (5) days. If the kitten is found to be unhealthy, he/she may be brought back to **Catera Cattery** for treatment by the veterinarian employed by **Catera Cattery**. A replacement kitten or refund will be given **if it is the fault of** Catera Cattery. **Catera Cattery** will not be responsible for veterinarian expenses incurred, except for **Catera Cattery** personal veterinarian.

This cat/kitten comes from a **FeLV Free** Cattery, meaning no cat(s) /kitten(s) test positive for FeLV nor are they vaccinated for FeLV.

Under NO circumstances will the kitten be accepted back after the guarantee has expired, OR the kitten has been exposed to a cat who has not been FeLV and FIP tested negative!

FIP is an uncommon disease that is not 100% preventable. **Catera Cattery** waives liability for FIP and any related veterinary expenses. I suggest you should take out a Veterinary Insurance on the cat/kitten for 2 years.

NOTE: This Guarantee is null and void if the Leukemia (FeLV) and/or FIP vaccination(s) is/are given

I have bred selectively in order that your kitten may have a long and healthy life. Every cat/kitten purchased from Catera Cattery will be fully **vet-checked and certified to be healthy and free of any disease or parasites at the time of sale**. Your kitten is health guaranteed until its **first year of age for genetic defects ONLY**. If you feel that the kitten suffered or is suffering from a genetic defect, the guarantee only applies when the genetic defect has been identified by a licensed veterinarian, or in the way of an autopsy report, stating clearly this kitten died of a genetically related defect. Catera Cattery will replace the kitten after receiving a written pathology report from a board certified pathologist.

Buyer is responsible for all veterinarian fees from the date and time of shipping.

Return of cat/kitten for health reasons will be at Buyer's expense, **MUST** have been identified by a licensed veterinarian, and be accompanied by the veterinarian's initial examination statement, showing that health problem(s) exist **AND that the health problem must have existed prior to the sale** of the cat/kitten.

Stress induced URI is not covered in this medical statement.

Seller's remedy for any health problems covered in this contract will be limited to replacement of cat/kitten with another cat/kitten of equal value.

This Guarantee is limited to replacement of kitten only at earliest availability - NO REFUNDS!

Payments and deposits are non- refundable unless Seller cannot supply the above cat/kitten

If the kitten gets sick or dies for any other reason than from a genetic defect, there is NO Guarantee!

Once my Vet has certified the kitten as being healthy, I am no longer responsible for the kitten after he/she has left my home with all paper work (medical records). As stated in the second paragraph of this contract, you have 5 days to have the kitten examined by your own Vet. I cannot control the stress of the kitten when they leave my home, nor can I be held responsible for any illness the kitten may contract or injury he/she may sustain while in your care!

I am interested in the welfare and the health of my kittens and an occasional note or phone call to let me know how your newest member of the family is getting along would be greatly appreciated.

This kitten has been sold as a **Pet only and is not to be used for breeding purposes** under any circumstances. If this kitten should at any time produce (even if not eligible for registration), Breeder price would then apply to the kitten, which would require the additional payment of **\$1000.00** to Catera Cattery.

This kitten will not be sold or placed in another home without contacting Catera Cattery first. I expect you to keep your cat safe from automobiles or theft by not allowing him/her outside of your home or secure outdoor area.

If this cat/kitten cannot be cared for any longer, purchaser agrees to contact Seller first for new placement options. Placement in a new home will be pursued by the Seller.

Any dispute concerning this sale will be conducted in **Elmore County in the State of Alabama**

Signature of buyer indicates full agreement and approval of all above and below conditions and limitations.
